## **Committee/Liaison updates and reports:**

National Night Out, Tues Aug 7th Mike committed to be chair committee for 2019 NNO. To consider for next year – (1) decreased number of gluten free items as they were expensive and not utilized. Motion that this year's surplus be donated to an appropriate nonprofit, made, seconded, and passed without dissent. (2) Early recruitment of fire trucks and the like. (3) Consider whether 'bouncy house' is an appropriate expenditure given the small number of children attending and the potential to distract from safety education purpose of event

**Listsery rules.** Board members unprepared for discussion, tabled, to be taken up at September's meeting

**NPNA FTR external organizations policy.** Seconded, approved without dissent.

**Annual Financial Review Guidelines.** Rules for financial review were approved (this will become Article VI Section 4 of bylaws)

Financial review template was approved.

Regarding Request for Additional Funding, discussion centered on if expenses are likely to exceed budget and approval form is submitted, how to proceed. Consensus is that form would be submitted to full board for online voting under online voting rules. Referred back to committee to update wording and bring back to Board for approval. General discussion around the need to adequately budget, and to allow sufficient time for planning, so as to avoid last minute requests.

**Bylaws Section I & II** Diversity wording adjusted to include the phrase 'including but not limited to' so final wording of addition to Section I is:

Northgate Park Neighborhood Association does not discriminate for any reason including but not limited to race, color, national origin, religion, sex, gender identification (including gender expression,) sexual orientation, disability, age or any status protected by law or regulation.

Article II Section 1 (paragraph 2) was discussed and approved to change: "one vote casting" to "Only one vote may be cast by a business."

Both sections approved without dissent.
