## **Old Business:**

Steve Loziuk (Transportation Division, Public Works Department, City of Durham) has corresponded with Cheryl in a follow-up from November 2004 meeting.

Speed data compiled, and we fall in the 85% percentile of speeds <35mph.

We now have a Yield sign on Higbee and Farthing, replacing the old Stop sign

KFC parking lot facing Roxboro Rd is encroaching on the right of way, and Steve will contact State dept. to see if this problem can be corrected.

Limiting turns on all 3 streets (Higbee, St. Paul, Davidson) is the only alternative to the speeding problem

City of Durham will get the signal lights fixed (timing plans are based on time of day)

Steve to follow up at February 2005 meeting on above items. Number to reach him at is: 560-4366

Locked Doors on Park rest rooms:

City has drained water from toilets to prevent freezing and bursting of existing facilities, and the rest rooms will re-open in the spring of this year, hopefully by the beginning of April.

Northgate Park Renovations:

John Woods, lead landscape architect for the project, indicates that stream renovations of Ellerbee Creek will impact park design, and it will be March 2005 when they will report back to us on Park renovations proposals discussed at our November 2004 meeting.

Cheryl Sweeny has spoken with Patrick Baker, new Durham City Manager, regarding the loss of the original funds set aside for Northgate Park renovations: the original \$300,000.00 approved for renovations has now shrunk to \$150, 00.00. Northgate Park Association members are encouraged to get involved with contacting city officials to find out where the money went!

## **New Business:**

Our featured speaker for the evening, Sergeant Howard Alexander, Gang Unit-Durham Police Dept, was unavailable to come to our meeting due to being involved in a case on the evening of 01/20/05.

A Pot luck diner for our March 2005 meeting was proposed and approved.

Neighborhood "Scams" discussed: do not open your house to strangers, call 911 and report incidents to police.

District 2 Sub Station will do house checks while you're gone on vacation/business, and the COPS patrol also assists with this service, Eric Hester from Durham Police

Dept will hold information meetings regarding security checks on homes and property for interested individuals.

A new neighborhood association, **Colonial Village**, has been formed - this includes Banner and Ellerbee streets. They are proposing to set up cameras to watch Club/Roxboro intersection at the BP station for gang/drug activity.

Pauline Bullock, Neighborhood Watch Captain of St. Paul street, reports that the Joy Convenience store and BP station both have **problems with gang activity and homeless people** at all hours of the day. Davidson Street has the biggest problem with gangs and homeless. Discussion of the 4 local pay phones (located at Shell station, Joy store and American Hero) are being used for drug contacts- the owners of the Joy and American Hero business are willing to cooperate with police in efforts to curb crime activity.

Suggestion made by Mike Schiflett to provide a description of suspects involved, license plate # on car along with description of make and model of car, and the Selective Enforcement Team can build a case against them with surveillance.

We have had a problem with drug activity for ~12 years now in our neighborhood, and as a Neighborhood Association, we can draft a letter to be sent to Durham mayor Bill Bell, Patrick Baker, Durham City Manager, and members of the Durham City Council to meet with us and address our concerns.

Tracey Jalbuena has kindly offered to draft letter this letter.

Owners/operators of our local businesses also need to be involved in this effort!

## Action Plan Assignments made:

Pauline Bullock is to contact the local business owners to find out their willingness to remove the public pay phones.

Bill Ellingsworth is to contact American Hero business to see if neighbors and businesses can meet there for a discussion of a neighborhood watch against crime.

Eric Hester (City of Durham) can come and do a "Neighborhood Watch" presentation at a church or possibly the Civitan Club.

CALL 911 to report any suspicious activity in our neighborhood-it gets calls logged into the police station, and involves them in our efforts to make Northgate Park a safer place to live!

Drafting/sending letter to Durham city officials discussing our need to meet with them and discuss neighborhood problems. As mentioned above, Tracy will draft a letter on our behalf.

**Draft of letter to be sent to City Manager Patrick Baker and Durham City Council read by Tracy Jalbeuna**. Discussion regarding additions to letter included: detail regarding the incident that occurred in January 2005 in our neighborhood with shooting death of a "gang member" on Roxboro Rd. A suggestion was made to come up with our own neighborhood plan for crime prevention and address this in a letter, rather than assume that police will take care of everything for us without neighborhood watch and involvement. And also to cc: Durham Police Chief Steve Chalmers a copy of final letter.

Motion was made requesting Tracy to implement the 2 additions to her existing GREAT letter, and we will photocopy signatures to the final copy from our sign up list from tonight's meeting.

Our guest speaker at tonight's meeting was Sergeant Alexander from the "Gang Unit" in the Durham Police Department, who gave us **a talk on gang activity in Durham**. Gangs are formed to make money, and drugs are the way of making big money in the shortest amount of time, the prominent gangs in our area are: Crips, Bloods, and Folks Nation. Sgt Alexander made us aware of the gang signs associated with Folks Nation, the six pointed star, each point representing: Love, Life, Loyalty, Wisdom, Understanding and Knowledge. Another gang is known as "8 Ball" and these are members of the Folks Nation and Crips who "run" together. We had an explanation of the 3 world orders according to gangs:

1st World People: regular citizens who seek education, work, pay taxes, and are considered "regular" citizens.

02/17/05

2nd World People: those that slightly delve in drug activity

3rd World People: people who live in chaos-deal in and with drugs, money and murder.

Sgt Alexander explained that young people are heavily recruited by gangs because juveniles will not be prosecuted under our existing laws. We learned about the Folks Nation symbol: A three pointed sign (?) representing Mind, Body, and Soul. The culture of gangs is completely different on the West coast, according to Sgt. Alexander. But one fact does remain: all deaths between rival gangs have the retaliation factor-the police do not know when or how it will happen. We learned that the gang colors for Crips are blue, Bloods are red, and Folks Nation is black. The gang culture embraces violent themed music, and violence against women. Gangs are urban terrorists, recruit their new members at schools, and we as a neighborhood should continue to fight their presence by reporting gang signs in public places to the police, having neighborhood watch groups to be alert to suspicious activity by gang members, and calling police when it occurs.

## **New Business:**

March meeting will be a potluck dinner at the Civitan Club. John Wood from Cline Associates will be there, as well as John Wood from City of Durham to discuss plans for Northgate Park. Patrick Baker, City Manager of Durham, is also expected. Please bring a dish to share, and new faces are always welcome!

April 16th is Northgate Park Clean Up day-8AM till 1:00PM. Bring loppers, small shears, tarps, and we need plenty of manual labor to bring debris to the curb for city pick up.

## **Traffic Calming:**

Phil Losiack sent letter with diagram for traffic calming that he says is "gaudy." Cheryl says speed bumps on Farthing may be best option.

## Northgate Park Renovations:

Cline Design team was present at meeting to introduce their ideals for park renovation, all present were given color layouts with their ideals.

The first suggestion given was meandering water channel (slow down water flow to reduce stress on banks of creek), or move it completely. Design phase will determine hydraulics. Native plants will be used as replacements (willows, dogwoods, alder were some examples given)

Plan design is due in ~6 months.

Late summer 2006 will be start of construction in Park, and October/November 2006 will be start of planting in park. Design plans should be finalized by September 2005.

Some concerns voiced from the neighbors included:

The master plan far exceeds the budget!

Protection for existing trees (some of which are 60 years old), Beaver concerns- estimate that they have cleaned out 80% of trees planted in 1999 in Northgate park, and lighting for the park is still to be investigated-more lighting is definitely needed, and security lighting on structures is also a big concern.

Mosquitoes are another concern for any water design in the park, and saving the stone entrance ways on Club Blvd and Glendale Ave was also voiced.

The design team had questions:

"How to make contact with the parents of Club Blvd school age children, to find out what they want?

Bike paths was a suggestion, and thought from Lisa to have the team go to the park on a nice weekend day and make inquiries for the children then.

"What do people want out of their park?"

A suggestion was made to design building that would be "anti-graffiti" to replace existing structures.

Perimeter lighting- we need to have lighting after dark and early morning for the walkers. Request for old neighborhood park history from some of our long time residents was also voiced.

March meeting minutes amended to include the sapling sale

Guest Speaker: Kevin Lilly, Durham Urban Forester, "Our Urban Forest & How to Care for It"

Kevin opened up his talk with the statement that our trees have taken abuse from the Power line company due to floods and ice storms in the past. Their biggest challenge is to work with the urban foresters. The City of Durham has no plan for replacing large trees when they die. Kevin's group is introducing a list of trees that can live under power lines. His crew of 4 arborists has turned into a "reactive" force-they remove a dead tree when it's called in, just as fireman will do for a fire. There is federal Grant money available for Forest service-they are hoping to remove 100 of worst oak trees with a 3 way money match with City of Durham and Duke Power. Kevin has indicated that no trees will be planted in Northgate Park until restoration is set and complete.

A question was raised regarding city support of the trees, but Kevin`s take is that crime, downtown rejuvenation is more important than trees, and Neighborhood Street Tree Program budget may be cut. Kevin's group is responsible for maintaining city property and city right of ways for trees taken down and planted. He also meets quarterly with Duke Power to present point of contact with each area being pruned by Duke Power.

The Urban Foresters are currently using an outdated bucket truck. Kevin has put in the budget for a new truck, as well as 2 additional arborist to the group, hopefully by July 2005. A suggestion was made to get a subcommittee formed from Northgate Park, and do a survey of our tree population to give information for the "Tree Sharing Program".

Kevin's tips for care and feeding of our old trees: Physiology of roots is key to their survival. Nutrients come 3-4' of roots. Keep grass and plants away from tree-3" layer of mulch is better around the base of trees (leaves, pine straw, bark chips) DO NOT PARK OR DRIVE NEAR ROOTS! Avoid 3-4' around trees when fertilizing your yard. In extreme heat-Water the tree-Not the lawn! Nature will prune the tree naturally, so remove dead wood and diseased limbs only

# Presentation of Master plan for Northgate Park by Cline Design Associates and Durham Dept of Parks and Recreation: Tanner Weeks and John Wood

Discussion of park design: 2 options

- (1) South existing corridor move to east. Regrade to eliminate stagnant areas.
- (2) North existing corridor, no realignment due to trees.

Key Points:

- tennis courts
- landscaping
- specimen tree preservation
- consolidation of playground equipment near tennis courts
- Incorporation of loop walkway with existing trails (upgrade to 5'-6' wide concrete trail)
- New bridge where existing one is (funded by Stream Restoration)
- Eliminate road by tennis courts
- Picnic area in central location

2005 bond would allocate \$314,000.00 to Northgate Park, and previous bond would contribute \$150,000.00. Grading around existing picnic shelter, recapping stone markers, upgrade on restrooms.

Discussion regarding a dog park in Northgate Park utilizing ball park area that is in poor shape. Time table estimated to begin in 2006. After site plan approval, future presentations will include choices of playground structures, color selection, and park lighting.

Ellerbee Creek Association is very interested in renovations to come.
