<u>Presentation by Nate Baker – Expanded Housing Choices</u>

Starting at 6:06pm, Nate Baker, City Planning Commissioner and Northgate Park resident presented details of Durham's Expanded Housing Choices, EHC.

17 NGP residents attended with two from Trinity Park and one from Colonial Village.

The City is about to embark on a new Comprehensive Plan within the next few months which will hopefully start to address the causes of bad planning spanning the past 70 years. Durham population forecast to grow by160k new folk over the next 30 years Planning decisions tend to be pro-developer. In just the past six months Nate has been a Commissioner, more than 330 acres have been approved for development on the outside of the City.

UDO – Unified Development Ordinance. Antiquated standards, sprawl driven by reliance on automobiles, no sustainability requirements or green building. Future Land Use Map is frequently appealed to make zoning changes.

Nate gave an explanation of intent of EHC and the tools to be used to improve density. 2015 NC GOP eliminated design standards for single family and duplex houses. Rent control is illegal in NC

Every attendee was given the opportunity to comment and question Nate.

Final version of the EHC included in agenda 1.5 weeks before May Planning Commission meeting.
