Mary Calvopina of Durham CAN (Congregations, Associations and Neighborhoods) presented a summary of CAN's aims and answered attendees' questions.

CAN is an organization of organizations and trains community leaders. CAN is currently focused on affordable housing and jobs. Examples of CAN's successes include: Getting the Durham Housing Authority to purchase 19 acres of land downtown and commit to buildings that would benefit the neighborhood.

Two acres in the middle of downtown designated for 80 units of affordable housing with Self Help likely a co-developer.

Two acres alongside the bus station designated for affordable housing in addition to parking.

CAN's approach is to come with solutions not just complaints.

Topics are identified and researched through listening sessions. 2000-2500 people polled with each group identifying three issues. CAN leadership then tabulate those issues and an Assembly of around 300 from member organizations whittle this down to the top three issues.

Membership dues are 1% of operating budget with a minimum of \$1000 and a max of \$10,000. Only two neighborhoods are currently members, Watts Hillandale and an unnamed group close to Jackson Street.

The next Assembly to identify issues to address will be in May/June CAN closely follows the principles of IAF (Industrial Areas Foundation).
