Getting new shelters on Roxboro will be driven by number of riders. An article for the newsletter might encourage more riders.

<u>Financial review committee report</u>:

Co-working: Tom and Kara have been working with the St Paul's Methodist Church and coffee house about having a co-working opportunity there starting perhaps 2 days a week, paid by a voluntary contribution. Also there is a coffee shop where people could hang out, two round tables, rows of chairs, coffee and drinks, and a back section that is carpeted, two bathrooms and a picnic shelter. Someone will need to be there 9-5 on designated days.

Donald Clary: Elgin St Halloween. Info is turned into the city, awaiting permit. Only Burger will be there, working on entertainment. Plans to be as big and fun as ever.

Deb: Braggtown has a neighborhood association. Raises possibility to liaison with them as we are with Colonial Village. If our neighborhood wants to draft a resolution they can submit it to INC. Deb has more information about addressing the violence in Durham.

Walltown has some information about the development of Northgate Mall.

Deb raised the question of reimbursing the food trucks for the vouchers given to the musicians. Keith will reimburse the vouchers this month.
